WAR RISKS – REVISIONS TO THE LIST OF AREAS OF PERCEIVED ENHANCED RISK

In accordance with the Terms of Entry for Hull and Machinery War Risks including “Navigation Limitations for Hull War, Strikes, Terrorism and Related Perils Endorsement (JW2005/001A)”, Notice of Cancellation is hereby given in order to amend the List of Areas of Perceived Enhanced Risk currently in “Hull War, Strikes, Terrorism and Related Perils Listed Areas (MM Clause No. 2511)”.

A new List of Areas of Perceived Enhanced Risk is attached in “Hull War, Strikes, Terrorism and Related Perils Listed Areas (1 December 2009) (MM Clause No. 2530)”.

The following area is amended :-

Africa

Indian Ocean, beyond the eastern Somalia and Gulf of Aden areas out to 600 nautical miles from the coast of eastern Africa, south of latitude 15°N and north of latitude 10°S, but excluding the coastal waters of Kenya and Tanzania up to 12 nautical miles offshore.

Amended to read :-

Africa

Indian Ocean, the area beyond the eastern Somalia and Gulf of Aden areas out to 65°E south of latitude 15°N with the southern boundary being 18°S but at 49°E, the boundary shall extend due south then east along the latitude 12°S, but excluding the coastal waters of Mozambique, Kenya and Tanzania up to 12 nautical miles offshore.

Philippines, but only

Mindanao, between the ports of Polloc Harbour and Mati inclusive.

Amended to read :-

Philippines, but only

Mindanao, between the ports of Polloc Harbour and General Santos inclusive.

In addition, the following area is deleted.

Indonesia / Malaysia

The island of Ambon (Seram)

The port of Poso (Sulawesi)

This notice is effective from 24.00 hours GMT 4 December 2009 and will become effective at 24.00 hours GMT 11 December 2009.

This contract shall be considered as automatically reinstated upon expiry of the notice period, subject to the listed areas being amended to reflect “Hull War, Strikes, Terrorism and Related Perils Listed Areas (1 December 2009) (MM Clause No. 2530)”. All other terms, clauses and conditions remain unaltered.

Notice must be given to the Company before an Entered Ship proceeds into a Listed Area as defined in "Hull War, Strikes, Terrorism and Related Perils Listed Areas (1 December 2009) (MM Clause No. 2530)". The Company will endeavour to provide indications of additional premium levels at any time but quotations will not normally be available until the Entered Ship is within 48 hours of arrival into the Listed Area.
